FORM 'A' CHECKLIST

The following items MUST be shown on an ANR (Form 'A' application):

1. The minimum dimension for a plan submitted shall be 8 ½ “ by 11”
2. The plan shall be prepared by a Registered Massachusetts Land Surveyor
3. The plan shall indicate the name of the landowner of record and the location of the land being divided.
4. The plan shall include a statement “Approval Under Subdivision Control Law Not Required: and shall provide sufficient space for the date and the signatures of at least three (3) members of the Dalton Planning Board.
5. The plan shall show all zoning classifications and the location of any Zoning District boundaries that may lie within the locus of the plan.
6. If a new lot or lots are created, the remaining land area (square feet) and the frontage (feet) of the land remaining in the ownership of the applicant shall be shown.

Mylar and seven (7) copies of plans and seven (7) completed & signed Form 'A' applications.
Filing fee: Number of lots x \$25.00 plus \$75.00 filing fee **OR** number of lots x \$150.00 plus \$75.00 filing fee for any lots created within eight (8) years of the approval of that subdivision by the Planning Board.

All forms & plans will be date stamped by the Town Clerk.

Town Clerk will receive (1) copy of the plans and one (1) copy of the application

Must be done within twenty-one (21) days

Mylar will need three (3) signatures of Planning Board Members
